



### **Norfolk's Care Convention on hold – 31 July 2018**

As many of you will know, the Market Development Team at County Hall is the lead department for the Council's involvement in the care convention. As part of the wider commissioning function, we are currently awaiting a review of our structure and activities. Discussions are also underway for the formation of a formal "Care Association" for Norfolk – an umbrella body for providers of adult social care. In view of these major changes, we feel it is wrong to commit to the preparations for a care convention at this time. We propose to put a hold on any preparatory work pending some clarity about the future. If the situation becomes clear sufficiently quickly, we will endeavour to meet the planned November slot for the convention. However, it may be necessary to delay the convention date to allow sufficient time to plan and prepare. We will contact you when we have a clearer picture. We will consult with you about your ideas for a revised date if a change becomes necessary. It is important to say that if partners wish to proceed with an event in November, without the guaranteed involvement of NCC, we would not object. The event, after all, belongs to us all.

## Social Care National Recruitment Campaign

Caroline Dinéage, the Minister of State for Care, has publically committed to launching a new adult social care campaign this coming autumn. The campaign hopes to raise the image and profile of the sector and highlight the variety of careers on offer in order to attract the right people with the right values, who will deliver the very best care. Earlier this year Skills for Care carried out a gathering and scoping exercise which showed the need for a national recruitment campaign. The campaign launch date has not yet been confirmed, however we will be providing further information on this when we have it.

## Beyond Barriers: how older people move between health and care in England

We have published a report following the completion of [20 local authority area reviews](#) exploring how older people move between health and adult social care services in England.

[Beyond Barriers](#) brings together key findings and recommendations for change, as well as highlighting some examples of health and social care services working well together, and of individuals working across organisations to provide high quality care.

The report recommendations include: reform of planning and commissioning of services; a new approach to system performance management; joint workforce planning; and better oversight of local system performance.

## Reforming the Deprivation of Liberty Safeguards system

On 4 July 2018 a new Bill was introduced to the House of Lords to reform the current Deprivation of Liberty Safeguards (DOLs) system. The current DOLs system places a disproportionate and significant burden on the adult health and social care system and because of a current backlog vulnerable people are not being protected in line with their human rights. Close work with stakeholders, and following a Law Commission Review, has led to the reformed model which will increase the protection of vulnerable people, carers and their families, as well as health and care professionals.

## New Guide to help with complaints and feedback

The Local Government and Social Care Ombudsman and Healthwatch England launched a new guide to help care providers see best practice in receiving and dealing with comments, complaints and feedback about their services. The new single complaints statement sets out what service users, their families and representatives can expect when making a complaint or leaving feedback.

Born out of the Quality Matters initiative, which aims to improve the quality and consistency of adult social care provision across the country, the statement offers a simple bulleted guide for each stage of the complaints process. ## Financial scams and National Trading Standards - raising awareness

The National Trading Standards (NTS) Scams Team estimates that between £5 and £10 billion a year is lost by UK consumers because of scams

This has led to the Friends Against Scams initiative, which aims to protect and prevent people from becoming victims of scams by empowering communities to 'Take a Stand Against Scams'.



53% of people aged 65 and over have been targeted by scams and criminals, and only 5% of victims report the crime. The scheme encourages people to get involved to protect each other from becoming vulnerable to a scam. ## Trusted Assessor Guidance

'Trusted Assessor' schemes are a national initiative designed to reduce delays when people are ready to be discharged from hospital. It is based on providers adopting assessments carried out by suitably qualified 'Trusted Assessors' working under a formal, written agreement.

Research has showed that delayed discharges can have a significant negative impact on people's well-being, and there are also risks associated with premature or poorly planned discharges. Assessments and care planning can be undertaken by Trusted Assessor schemes in a way that meets people's needs as well as legal requirements on providers. To achieve this it is vital participants have confidence in the scheme.

Our new guidance sets out how Trusted Assessor agreements can be set up to meet people's needs and legal requirements, including [guidance](#) on what should happen when adult social care services

have concerns that inappropriate discharges are being made.

The 'Emerging Concerns Protocol' seeks to provide a clearly defined mechanism for us to share information and intelligence that may indicate risks to users of services, their carers, families or professionals.

## Annual Provider Survey

Earlier this year we undertook our 2018 Annual Provider Survey, inviting a representative sample of almost 30,000 providers to take part.

We are currently analysing the results and developing action plans in response to the feedback we've received. So far the key findings from Adult Social Care Providers are:

- Our registration process is generally seen as positive and a large majority of providers feel it helps them understand the commitment they are making to safe, high quality care.
- There is a positive view of the inspection process with recognition that judgments are fair, based on evidence and there is enough flexibility to accommodate new models of care.
- When Adult Social Care providers are aware of our Independent Voice publications they are likely to take action as a result.
- A majority of ASC providers agreed that CQC's regulatory approach helped their service to improve, with one of the key factors being the service's inspection report.
- Consistency of approach and consistency of judgments remain a concern for Adult Social Care providers, and this has been agreed as an improvement priority for CQC.
